**ORDER: DENYING Defendant Rote's Motion to Vacate [330]. Defendant Rote has failed to demonstrate fraud on the Court under Fed. R. Civ. P. 60. See *England v. Doyle*, 281 F.2d 304, 309-10 (9th Cir. 1960) ("In order to set aside a judgment or order because of fraud upon the court under Rule 60(b), it is necessary to show an unconscionable plan or scheme which is designed to improperly influence the court in its decision... [T]he burden is on the moving party to establish fraud by clear and convincing evidence."). It has also come the Court's attention that Defendant made inflammatory and disparaging remarks about the individual jurors sworn to try this case, and it appears that Defendant may have attempted to contact at least one of the jurors post-trial. Defendant is reminded that the Court previously ordered the parties not to initiate contact with any juror sworn to try this case. See Order, ECF 289.
